

# INTRODUCING JOBMAKER

The Personnel Group has some important information for you regarding the Federal Governments recent budget announcement.

The JobMaker Hiring Credit will help to accelerate growth in the employment of young people during the COVID-19 recovery. This will improve their economic, health and social outcomes and reduce the scarring from long-term unemployment.

Eligible employers will be able to claim \$200 a week for each additional eligible employee they hire aged 16 to 29 years old, and \$100 a week for each additional eligible employee aged 30 to 35 years old who have worked at least 20 paid hours per week on average for the full weeks they were employed over the reporting period.

## **Employer eligibility**

Employers are eligible to receive the JobMaker Hiring Credit if they:

- have an Australian Business Number (ABN),
- are up to date with tax lodgement obligations,
- are registered for Pay As You Go (PAYG) withholding,
- are reporting through Single Touch Payroll (STP),
- meet the additionality criteria\*\*
- are claiming in respect of an eligible employee, and
- have kept adequate records of the 20 paid hours per week worked by the employee they are claiming the hiring credit in respect of.

\*\* The business' total employee headcount (minimum of one additional employee) from the reference date of 30 September 2020, and the payroll of the business for the reporting period, as compared to the three months to 30 September 2020.
